		ii. In the event that any ATM is out of money for more than 72 hours due to negligence of any of either party the Agreement
		for that ATM can be immediately terminated by the non-negligent party at its sole discretion.

	a.	ATMs are 100% owned by ATM Owner. Loader shall not under any circumstances sell, encumber, pledge, mortgage, or perfect a
		lien against the ATM equipment.
	b.	Loader maintains full title to, ownership of and responsibility for all cash in the ATMs and agrees and acknowledges that Service
		Provider alone shall bear all risks of theft, loss or destruction of such cash.
3.	Respon	sibilities
	a.	Owner
		i. Owner will provide processing services for the ATMs and provide Loader access to the online reporting tool.
		ii. Owner is responsible for the proper operation of the ATMs ensuring the ATMs have the current software and are
		compliant with industry regulations.
	b.	Loader
		i. Loader will furnish all cash, load, and monitor cash levels for the operation of the ATMs.
		ii. Loader will reasonably maintain cash levels at all times ensuring there is sufficient cash to satisfy reasonable ongoing
		cash withdrawal requirements for each ATM.
		iii. Loader shall also provide, on an as-needed basis, First Line Maintenance (fixing receipt paper jams, bill jams,
		replacement of receipt paper and all other ongoing basic maintenance services customarily applicable to retail ATMs) in
		an expeditious, but reasonable time frame at no additional charge.
4.	Compe	
	a.	ATM Owner will compensate Loader on a case-by-case basis for each successful withdrawal transaction at the ATMs.

	a.	Loader agrees that at no time, throughout the duration of this Agreement and after termination of this Agreement, is it permissible
		for the Loader, or any of its affiliates, to, directly or indirectly, solicit, or attempt to solicit Owner's customers, clients, or accounts
•		for ATM placements, cash loading, repair or maintenance work.
6.	-	dent Contractor Relationship
-	a.	The Parties agree that this Agreement creates an independent contractor relationship only, and not an employment relationship.
7.	Notice/	
	a.	All notices related to this Agreement can be made by mail or electronic mail.
	b.	This Agreement shall be interpreted under, and governed by, the Laws of the State of The parties hereto agree

that any action relating to this contract shall be instituted and prosecuted in the Courts of the ______ County,

___ (state), and each party hereto waives the right to change of venue or trial by jury.

c. The prevailing party in any dispute under this Agreement shall pay all costs and expenses, including expert witness fees and attorneys' fees, incurred by the prevailing party in resolving such dispute.
